## 2. Login

To access the software, kindly visit <u>https://mybankstatement-nibss.net</u>. Ensure you have received the system generated sign up email containing username (email address) and default password and have changed your password.

To gain access to the portal, kindly provide your username and password and click the Login button.

You can electronically request for customers' account statements directly from the bank using the mybankStatement® portal, the customer will receive an SMS with the mybankStatement® ticket details and an email with the mybankStatement® ticket to be used for authorizing the request, the ticket details or mybankStatement® ticket is then forwarded to your organization to be used in accessing the statement.

- a) <u>Initiate Statement Request</u> To request for an account statement, Input the account number, select the bank, select the period of statement to be requested, select the role of the account owner (e.g. Applicant, Sponsor or Guarantor), input the phone number attached to the account at the selected bank, and then input the applicant name(s). Ensure the details provided are correct and click send.
- b) <u>Confirm Ticket</u> The transaction is then logged to the "Statement Request" table where the status is "Pending", the details are verified and the account owner is issued an SMS containing Ticket details and an email with mybankStatement Ticket attached. This is to be shared with your organization to allow you access the statement. The status of the transaction changes to "Ticket Sent",

Click the Confirm action link to input the Ticket Number and Password provided and click Confirm

c) <u>Download Statement</u> - Once the Ticket Number is confirmed, the account statement can be viewed in the "Inbox" menu item and can then be previewed.

Note: Email notifications are also sent to keep the requesting officer apprised of the progress or errors at every step of the transaction.
